1. The rates are to be quoted in percentage basis above / below / as per the following schedule of rates.
  - a. The APWD (Roads) Schedule of rates for the year 2018-19 & building 2013-14.
2. Tender without earnest money / incomplete tender will be summarily rejected.
3. The rate should be clearly quoted in figure and in words. In case of any discrepancies, the rate quoted in words shall be treated as valid.
4. No overwriting in rate will be accepted. Any correction / alteration must be signed with initials.
5. The undersigned reserve the right to reject any tender in full or in part without assigning any reason thereof.
6. The undersigned is not bound to accept the lowest tenderer.
7. The current registration No. and Name of Govt. Department must be noted very clearly.

8. Full name, Mobil No. and address of the tenderer should be mentioned very clearly.
9. Once the tender is opened and accepted, no request to enhancement of rate will be honoured.
10. The contractor will be fully responsible for any loss or damage of the materials and the value of the materials will be recovered double the cost of issue rate of the undersigned department from the contractor.
